(hereinafter referred to as "ANGS")

(hereinafter referred to as the "Hunter")

- of the Second Part

WHEREAS ANGS is a company lawfully incorporated pursuant to the laws of the Province of Alberta and carries on business of guiding and outfitting in the Province of Alberta.

AND WHEREAS the Hunter is desirous of entering into an agreement for engaging in the hunt of _____ for the period of _____.

WHEREAS the parties hereto are desirous of entering into this Agreement.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

1. The Hunter shall hire ANGS as a guide and outfitter for the period of _____ for the purpose of hunting _____ in the Province of Alberta.
2. The price of the hunt shall be the sum of US \$ _____ (U.S. Dollars) exclusive of transportation of the Hunter and his equipment to and from Edmonton, Alberta, and/or his accommodation while in Edmonton. (Prices includes GST rebate amount).
3. The Hunter agrees to provide a deposit of US \$500 upon execution of this Agreement with the balance to be paid to ANGS prior to the actual hunt commencing. This deposit is non-refundable.
4. All funds shall be by way of cash or certified check. ANGS will refund to the Hunter the full amount (less non-refundable deposit advanced) if notice of cancellation is given in writing sixty (60) days prior to the start of the hunt and the hunt is rebooked.
5. The hunt shall occur from time to time within the Province of Alberta at areas solely within the discretion of ANGS.
6. ANGS shall supply the Hunter with all transportation during the hunt from and back to Edmonton, all meals and accommodations during the hunt.
7. The Hunter acknowledges that he is an experienced and qualified outdoorsman and is aware of the inherent dangers of the wilderness. The Hunter shall be responsible to bring his own personal gear including, but not limited to knives, etc. and shall be responsible for the cost of securing a valid Alberta hunting license.
9. ANGS agrees that it will provide a minimum of one (1) guide for every two (2) Hunters for the duration of the hunt.
10. ANGS agrees that it will assist the Hunter in field dressing and transportation of any game taken from the hunt to the airport and will also assist in shipping meat/carcasses and in the processing of any trophy licenses.
11. The Hunter hereby releases and discharges ANGS from any claims for loss or damage however caused.
12. This Agreement shall be construed according to the laws of the Province of Alberta in force at the time.
